|  | WHAT WILL YOUR SON OR DAUGHTER BE ASKED TO DO?  Your son or daughter, and five others like her/him, will be given cameras and will decide as a group on several photo assignments that are related to After completing each assignment, they will all come back together to share and talk about their photos as a group. They will also be asked to write a little description of a few of your photos they shared with the group.  |  |
|  | If your daughter or son is interested in participating, you as a parent(s) or guardian(s) will be asked to attend an <i>Informational Meeting</i> . It is only necessary for one parent or guardian to attend. During this meeting (about ½ to 1 hour) you will learn about the project and have the opportunity to ask any questions. If your son or daughter decides to participate, they will be asked to sign an Assent Form to make sure that they understand the purpose of the project, what you will be asked to do, and that you can stop participating in the project at any time you wish. (Please note: You, as a parent or legal guardian must sign and return a copy of this Parental Consent Form during the Informational Meeting in order for your daughter or son to participate in the rest of this project). |  |
|  | If your son or daughter chooses to participate, they will be asked to attend about four meetings, or photo-discussion sessions, about 1-2 hours each with the others who participate. At the end of each meeting, they will decide on the topics they would like to explore with their cameras. This is called a "photo-assignment." They also will decide on dates and times when they will all come back together to discuss the photographs they have taken to complete the photo-assignments.  |  |
|  | At the Informational Meeting, the Principal Investigator,, will discuss ethical and safety issues about taking photographs. For example, if your daughter or son chooses to take pictures of other people, we will review a form that they will use to ask people for their permission before they take the picture. If they take a picture of someone 17 years old or younger, they will have to get permission from that person's parent or guardian as well. Your son or daughter will then receive a camera, tips on how to use it, and practice using a camera to make sure that they are comfortable with it.  |  |

| During the photo-discussion sessions, your daughter or son, the other participants, and will all meet together to discuss the photos taken to complete the assignments. They will be asked to give their permission to have these "photo-discussions" audio-recorded. If your son or daughter wants to have the recorder turned off for a while during the discussions, they will just have to tell the Principal Investigator to do so at any time. They may also refuse to be taped at all. |  |

| DO YOU HAVE TO PAY FOR ANYTHING FOR YOUR DAUGHTER OR SON TO TAKE PART IN THE PROJECT?  Your son or daughter will <i>not</i> have to pay anything to take part in the project. The cameras, the film, and film processing will all be free. The camera, if not a disposable camera will be returned to the at the end of the project. The only cost for being in the project is the time that your son or daughter will use for taking the pictures and coming to the discussion meetings.     |  |

Taking part in the project should not put your daughter or son at risk for physical harm. They may feel uncomfortable going out to take pictures, but we will discuss this at our meetings and talk about ways to feel more comfortable. Also, they may feel uncomfortable discussing some topics that come up. They do not have to, and will be reminded several times during the discussion sessions, that they do not have to talk about anything that makes them feel uncomfortable.

## WILL PEOPLE KNOW THAT YOUR SON OR DAUGHTER TOOK PART IN THE PROJECT?

To make sure what they say is confidential, your son or daughter can use a different name, a "nick name", during the study project so that nobody will see their real name connected with the project, if they prefer. Also, what other people say during the discussions is confidential, so no

To protect the identities of people who appear in their photographs, your daughter or son should no reveal their names during the discussions or anytime that their pictures are displayed.
